- Permittee, the members and organization, agree that permittee shall be responsible for insurance coverage, loss of personal property owned or possessed by permittee, his members and organization and make no claim against the district for loss or damage to such property arising out of condition of the function, and shall indemnify and hold harmless the park district, its commissioners, and employees for any such loss or damage to such property which arises from the function being conducted.
- Sound amplification devices, radios, tape decks, public address, musical instruments and the like are not permitted to be operated in a manner which may annoy other persons in the park.
- Any permit granted may be revoked for misrepresentation of material facts in the application, or violation of the terms and conditions on the permit, the ordinances, rules and regulations of the Belvidere Park District and the laws of the State of Illinois.
- A complete list of all Belvidere Park district Administrative Rules & Regulations are posted at the Log Cabin in Belvidere Park.
