## Approval of 2021 Appropriation Bill and Ordinance 21-03-01

Mary Marquardt made a motion to approve the 2021 Appropriation Bill and Ordinance 21-03-01, seconded by Sam An. A voice vote was taken. Mary Marquardt, Sam An, Paul McCaffrey and Jean Twyning voted yes. Mark Muccianti did not vote. Motion carried.

## 2021 Capital Project/Purchase Communication Log Approval

At the January 12, 2021 board meeting Todd Bex presented the board with ten capital projects exceeding \$24,999.99 for their review. Approving these capital projects would allow staff to proceed with the bidding and purchasing process.

Todd commented that the Digital Signage for Prairie Fields will be a 2-phase project. The first phase would be to provide power to the proposed site. The second phase would be design options for the board to consider.

Paul McCaffrey asked why the NASR Bus replacement wasn't included as a capital project for 2021. Todd Bex commented that this will be a capital item for 2022. Staff will be considering a new bus versus a van with a lift.

Mary Marquardt made a motion to approve the packet titled Project/Purchase Communication Log for Capital Project for the fiscal year 2021, seconded by Paul McCaffrey. A voice vote was taken with Mary Marquardt, Paul McCaffrey, Sam An and Jean Twyning voting yes. Mark Muccianti did not vote. Motion carried.

# Approval of Letter of Understanding Between Belvidere Cemetery Association and Belvidere Park District

The Belvidere Cemetery is constructing a new administration building off Fairground Road, with access to water from the watermain and connection to sewer located on Belvidere Park District property north of the Cemetery's property.

Mary Marquardt asked that language would be added that the Cemetery would have their own water/sewer meter and would be paying for their own water/sewer usage.

Mary Marquardt made a motion to table the memo of understanding, seconded by Paul McCaffrey. A voice vote was taken with all voting yes. Motion carried.

A voice vote was taken with all voting yes. Motion carried.

At 6:37 p.m. regular session reconvened. Roll call was taken. Those present were Mary Marquardt, Sam An, Paul McCaffrey, Mark Muccianti and Jean Twyning.

There was no action taken as a result of Executive Session.
