# Belvidere Park District Annual Levy Ordinance 21 - 12 - 01

Be it ordained by the Board of Park Commissioners of the Belvidere Park District of the County of Boone and State of Illinois:

SECTION I: The Board of Park Commissioners of the Belvidere Park District did on the day of April, 2021 ascertain the total amount of all appropriations for corporate purposes and recreational programs, legally made and to be collected from the tax levy for the fiscal year beginning January 1, 2021 and ending December 31, 2021, and by ordinance specified in detail the purpose respectively.

SECTION II: That a tax for the following sums of money, or as much thereof as may be authorized by law, to defray all expenses and liability of the Belvidere Park District of the County of Boone and State of Illinois, be and the same is hereby levied for purposes hereinafter specified against all property subject to taxation in the Belvidere Park District as the same is equalized and assessed for the State and County purposes for the fiscal year commencing on the 1<sup>st</sup> day of January, A.D. 2022, and ending on the 31<sup>st</sup> day of December, A.D. 2022.

Section IV: That the Secretary of the Board of Park Commissioners of Belvidere Park District shall make and file with the County Clerk of Boone County in the State of Illinois, a certified copy of this ordinance in order that the rate per cent may be ascertained and that said taxes so levied may be extended and collected, as provided by law.

Section V: This ordinance shall be in full force and effect from and after its passage and approval as provided by law.
