This incentive will include a property tax abatement of 85% for 5 years followed by 50% abatement for additional 5 years not to exceed 10 years in total for new EAV and support an extension of the Belvidere-Boone County Enterprise Zone program and an application beyond 2030; and commitment to grandfather existing property tax abatement schedules in the event the Belvidere-Boone County Enterprise Zone program is not available beyond 2030.
