AN ORDINANCE abating the tax heretofore levied for the year 2024, collected in fiscal year 2025 to pay debt service on the General Obligation Refunding Park Bonds (Alternate Revenue Source), Series 2020, of the Belvidere Park District, Boone County, Illinois.

WHEREAS, the Board of Park Commissioners (the "Board") of the Belvidere Park District, Boone County, Illinois (the "Issuer"), by Ordinance adopted on the 27th day of October, 2020 (the "Ordinance"), did provide for the issue of \$5,150,000 General Obligation Refunding Park Bonds (Alternate Revenue Source), Series 2020 (the "Bonds"), and the levy of a direct annual tax sufficient to pay principal and interest on the Bonds; and

WHEREAS, a duly certified copy of the Ordinance and Direction for Abatement of Taxes was filed in the office of the County Clerk of Boone County, Illinois (the "County Clerk"); and

WHEREAS, the Issuer will have Pledged Revenues (as defined in the Ordinance) available for the purpose of paying the debt service due on the Bonds during the next succeeding bond year; and

WHEREAS, it is necessary and in the best interests of the Issuer that the tax heretofore levied for the year 2024, collected in fiscal year 2025 to pay such debt service on the Bonds be abated.

NOW, THEREFORE, be it and it is hereby ordained by the Board of Park Commissioners of the Belvidere Park District, Boone County, Illinois, as follows:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2024, collected in fiscal year 2025 in the Ordinance, namely five hundred eight thousand dollars and no cents (\$508,000) is hereby abated in its entirety.

Section 2. Filing of Ordinance. Forthwith upon the adoption of this Ordinance, the Secretary of the Board shall file a certified copy hereof with the County Clerk and it shall be the duty of said County Clerk to abate said tax levied for the year 2024 in accordance with the provisions hereof.

Section 3. Effective Date. This Ordinance shall be in full force and effect forthwith upon its adoption.
